The attention of the Officers noted in the despatch entry is invited to the references sent in the reference 7th cited of this office.

In this office reference 7th cited detailed instructions were issued regarding the action to be taken to transfer various materials, equipments, files and registers and records to the concerned Officers as per the re-organised set up. All the Regional Deputy Directors of Public Health and Preventive Medicine and District Immunisation Officers and District Health Officers were instructed to prepare an inventory of all the files and items of materials and equipments etc. etc. in 6 copies. Accordingly they should have prepared a complete inventory of all the materials and equipments, appliances, machinaries, stores, stocks, furniture, stationary items including Typewriters, \*Calculators etc. and other accessories, drugs, disinfectants, Health Education materials, insecticides, files, records, registers and all items etc. etc. as instructed. They were also instructed to prepare six copies of the lists for each of the items viz. materials and equipments, appliances, Microscopies, machinaries furniture and equipments, stocks and stores, Health Education materials, stationary articles, Typewriters and its accessories Drugs and disinfectants, insecticides, running files, closed files and records, registers, currents and all other items. Two copies of such list in each category should have been submitted to this office duly furnishing the certificate of verification testifying to the correctness and with x reference to Stock Registers and their accuracy under their (Regional Deputy Director of Public Health and Preventive Medicine/District Health Officer/District Immunisation Officer as the case may be) signature with their names in Block letters within brackets. Instructions were also issued for distribution of the remaining copies.

In the reference sixth cited, Government have issued orders posting of two Deputy Directors of Public Health and Preventive Medicine (Health Services) in each of the Revenue Districts. The Deputy Director of Public Health and Preventive Medicine (Health Services) have already assumed charges and therefore the new set up has come into existence.

It is therefore necessary to confirm that pursuant to the instructions issued by this office, in the reference 7th cited six copies of inventory would have been prepared already and kept ready. Two copies of the lists in each item have not been received in the Directorate so far. It may be explained whether the inventory was prepared or not. They should sent the lists forthwith and bring with them to the Directorate when they attend the meeting on 6th and 7th May 1991 i.e. when they come for the meeting and hand them to the Director of Public Health and Preventive Medicine in person.

In the reference 8th cited, orders regarding the apportionment and allocation of the ministerial staff have been issued. Apportionment of other technical staff has also been issued in several other proceedings.

In pursuance of the orders issued in the G.Os cited, the following offices will be disbanded forthwith.

1. District Health Office, Kallakurichi

2. District Health Office, Tiruchengode

3. Offices of the Regional Deputy Directors of Public Health and Preventive Medicine, Vellore, Cuddalore, Tiruchirapalli, Madurai, Tirunelveli, Salem and Coimbatore and all the offices of the District Immunisation Officers and District Health Officers.

The ministerial staff and Office Assistants and others working in these offices are posted to the offices of the Deputy Directors of Public Health and Preventive Medicine (Health Services) and among other offices in the reference 8th cited.

Therefore all the items of records, files, stock and stores, furniture, materials and equipments, stationary articles Typewriters, drugs and disinfectants, insecticides, Health Education materials etc. of the above offices should be handed over as follows with the lists for each of the items correctly prepared.
