APPENDIX NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules.

The rules hereby made shall be deemed to have come into force on the 16th August, 1973.

RULES.

The General and Special Rules applicable to the holders of the permanent posts in Class II of the Tamil Nadu Public Health Subordinate Service shall apply to the holders of the temporary posts of Retoucher-cum-Artist and Junior Machine Winder in the State Public Health Press, sanctioned from time to time, in the Department of Health Services and Family Planning, subject to the modification specified in the following rules.

2. Constitution: The posts shall each constitute a distinct category in the said class of the said service.

3. Appointment: Appointment to the posts specified in the Column (1) of the Table below shall be made by the methods specified in the corresponding entries in column (2) thereof.

Retoucher-cum-Artist	i. by direct recruitment or ii. by transfer from the State Family Planning Press or by recruitment transfer from the Stationery and Printing Subordinate Service or if the Tamil Nadu Medical Subordinate

Junior Machine Minder	i. by direct recruitment ii. by transfer from the State Planning Press or by transfer from the State Printing Subordinate from Tamil Nadu State Subordinate Service.

4. Qualifications: (A) Age: No person shall be eligible for appointment to the posts by direct recruitment completed or will complete the age of 30 years on day of July of the year in which the selection for is made.

5. Other qualifications: No person shall be eligible for appointment to the post specified in column (1) of below unless he possesses the qualifications specified in the corresponding entries in column (2) thereof:-

Posts (1)	Qualifications (2)
Retoucher-cum-Artist	i. Must have appeared for Public Examination. ii. Must possess 3 years' experience in the trade that affords preference given to those who hold All India Certificate Litho Act.
Junior Machine Minder	i. Must have passed III VIII Standard in a firm. ii. Must possess two year experience in a letter Section in a printing Offset firm.

Provided: that preference shall be given to those who possess a certificate in letter minding Lithographic Printing issued by the Director of Technical Education, Madras or a Lower Grade Certificate in Lithographic Printing issued by the Government Examinations, Tamil Nadu.

5. Pay: There shall be paid to the holders of the posts specified in column (1) of the Table below a monthly salary calculated in the scale of pay specified in the corresponding entries in column (2) thereof:-
