NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 4th November 1988.

RULES

The General and the Special Rules Applicable to the holders of the permanent posts in the Tamil Nadu Public Health Subordinate Service shall apply to the holders of the temporary post of Warden, Multi Purpose Health Workers (Female) Training Schools sanctioned, from time to time, subject to the modifications specified in the following rules:-

2. Constitution:- The Post shall constitute a distinct category in Class I of the Said service.

3. Appointment:- Appointment to the post shall be made as follows:-

- (i) By promotion from among the holders of the Posts of Sector Health Nurse , (OR)
- (ii) By recruitment by transfer from among the holders of the post of Superintendent in the Tamil Nadu Ministerial Service in the Department of Public Health and Preventive Medicine.

4. Appointing authority: The appointing authority for the post shall be Director of Public Health and Preventive Medicine.

5. Qualifications :- No person shall be eligible for appointment to the post unless she possesses the following qualifications.

- (1) In the case of Sector Health Nurse must have put in a service of not less than ten years as Sector Health Nurse.
- (2) In the case of Superintendent in the Tamil Nadu Ministerial Service must have put in a service of not Less than three years in the Department of Public Health and Preventive Medicine.

(The person if appointed as "Warden" shall reside in the Hostel itself.

6. Sex:- Women alone are eligible for appointment to the post.

7. Probation:-

Every person appointed to the post shall be on Probation for a total period of one year on duty within a Period of two years.

8. Pay :-

There shall be paid to the holder of the post a monthly Pay calculated in the scale of Rs.5300-150-8300.
