NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Government of Tamil Nadu hereby makes the following rules.

(2) The rules hereby made shall be deemed to have come into force on the 5th February 1987.

RULES

The General and ^{Special} ~~Special~~ Rules applicable to the holder of the permanent post in Class I of the Tamil Nadu Public Health Subordinate Service shall apply to the holder of the temporary post of attendant to Walk-in-Cooler sanctioned from time to time, in the Department of Public Health and Preventive Medicine, subject to the modifications specified in the following rules:-

2. CONSTITUTION: The post shall constitute a separate category in the said Class I of the said service.

3. APPOINTMENT: Appointment to the post shall be made as follows:

- (i) by direct recruitment or
- (ii) by recruitment by transfer from any other service

4. APPOINTING AUTHORITY: The Appointing Authority for the post shall be the Director of Public Health and Preventive Medicine, Madras.

5. QUALIFICATIONS:

(a) AGE: No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete twenty eight years of age on the first day of July of the year in which the selection for appointment to the post is made.

(b) OTHER QUALIFICATIONS: No person shall be eligible for appointment to the post unless he possesses the following qualifications namely:

- (i) A pass in VIII Standard and
- (ii) Two years experience as Wireman or/ in Refrigeration Equipment.

6. PROBATION: Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years and the person appointed to the post by recruitment by transfer from any other service shall with effect on and from the date on which he joins duty, be on probation for total period of one year on duty within a continuous period of two years.

7. PAY: There shall be paid to the holder of the post a monthly pay calculated in the scale of pay of Rs.450-10-570-15-720.

Provided that, with effect on and from the 1st June 1983, the monthly pay shall be calculated in the scale of pay of Rs.750-12-870-14-940.
