ORDER:

The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

2. The Rules hereby made shall be deemed to have come into force on the 6th October 1998.

RULES.

The General and Special Rules applicable to the holders of permanent post in the Tamil Nadu Public Health Subordinate Service shall apply to the holder of the temporary post of Computer Operator in the Director of Public Health and Preventive Medicine, subject to the modifications specified in the following rules.

2. Constitution.- The post shall constitute a separate category in a distinct Class of the said Service.

3. Appointment.- Appointment to the post shall be made,-

- (i) by transfer from among the holders of the post of Computer, Computer-cum-Vaccine Store Keeper and Input and Output

Assistant in Tamil Nadu Public Health Subordinate Service
or

- (ii) by promotion from among the holders of the post of Entry Assistants in Tamil Nadu Public Health Subordinate Service, who have put in five years of service in the said post or
- (iii) by direct recruitment, if no qualified and suitable candidates are available for appointment by transfer or by promotion.

4. Appointing authority.- The appointing authority for the post shall be the Director of Public Health and Preventive Medicine, Chennai.

5. Qualification.-

(a) **Age.-** No person shall be eligible for appointment to the post by direct recruitment, if he has completed or complete 30 years of age on the first day of July of the year in which selection for appointment is made.

(b) **Other Qualification.-** No person shall be eligible for appointment to the post, unless he possesses a Bachelors Degree in Computer Science or Computer Application or Degree in Maths with Statistics or Degree in Statistics with Diploma in Computer Application issued by a recognised Computer Institution.

6. Probation.- Every person appointed to the post by direct recruitment shall from the date on which he joins duty, be on probation for a period of two years on duty within a continuous period of three years.

7. Pay.- There shall be paid to the holders of the post, a monthly salary calculated in the scale of pay of Rs.4000-100-6000 with effect from the 1st January 1996.

8. Saving.- Nothing contained in these Rules shall adversely affect the persons appointed to the post prior to the date of publication of these Rules.
