



The following notification will be published in the Tamil Nadu Government Gazette.

### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Public Health Subordinate Service (Section 26 in Volume III of the Tamil Nadu Service Manual, 2016)

2. The amendment hereby made shall be deemed to have come into force with effect on and from the 16<sup>th</sup> November, 1988.

### AMENDMENTS

In the said Special Rules, in rule 2, in sub-rule (a), in the Tabular column, under the heading "CLASS I", for item (i) and (ii) in column (2) against the entry, "30. Driver" in column (1), the following entries shall be substituted, namely:-

"Recruitment by transfer from among the holders of the posts in the Tamil Nadu Basic Service working under the control of Directorate of Public Health and Preventive Medicine and in the Department of Tamil Nadu State Health Transport".
