The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Basic Service (Section 19 in Volume III of the Tamil Nadu Services Manual, 1970):-

2. The amendments (1) and (2)(b) hereby made shall be deemed to have come into force on the 8th April 1993 and amendment 2(a) hereby made shall be deemed to have come into force on the 14th April 1983.

AMENDMENTS

In the said Special Rules,

- (1) in rule 9 for the clause (g), the following clause shall be substituted, namely:-

"(g) The unit for the purpose mentioned in clause (a), so far as the post of Office Assistant in category 5 of Class III in the Offices of the Labour Department, shall be as follows

- (i) Office of the Commissioner of Labour, Chennai and the Offices under the jurisdiction of Zonal Joint Commissioner Chennai;
- (ii) Offices under the jurisdiction of Zonal Joint Commissioner other than the Offices specified in item (i) above.

The appointing authorities within the jurisdiction of the said respective Zonal Offices shall exercise their functions in consultation with the Commissioner of Labour or the Zonal Joint Commissioner, as the case may be.;"

(2) in the Annexure, under the heading "Class III, IV and V",-

(a) after the sub-heading "Forest Department" and the thereunder in columns (1) and (2), the following sub-heading and entries shall be inserted, namely:-

"GEOLOGY AND MINING DEPARTMENT"

Geology and Mining Department	Commissioner of Geology and Mining, Chennai."

(b) under sub-heading, "Labour Department", after the entry "Office of the Commissioner of Labour" in column (1) and the corresponding entry in column (2) thereof, the following entries shall, respectively, be inserted, namely:-

"Office of the Joint Commissioner of Labour.	Joint Commissioner of Labour concerned".
