

In the G.O.cited a scheme of examinations has  
been prescribed for various Group Services and non-group  
services (technical) posts- vide details in annexure I and  
II of the G.O. Though a compulsory paper on English Subject  
has been prescribed for group services examinations  
no such paper has been prescribed for non-group services  
(technical posts) examinations. The Tamil Nadu Public  
Service Commission with a view to giving more importance  
to Regional Language subject has decided to include Tamil  
as an alternative subject to enable the candidate to  
choose either Tamil or English as a language subject under  
compulsory paper without effecting the minority candidates  
for all the examinations conducted by it with effect from  
1.9.93. In respect of non-group services (technical posts)  
besides introducing the new language paper with effect from  
1.9.93, the Commission has accided to provide 100 Marks to  
the new language paper and to effect necessary changes in the  
total marks for written and oral examinations in Annexure II.  
The Tamil Nadu Public Service Commission, has, therefore,  
proposed to the Government that necessary amendments to the  
G.O cited may be issued with retrospective effect from 1.9.93.

2. The Government, after careful considerations have decided to accept the proposal of the Tamil Nadu Public Service Commission and accordingly issue the following amendments to the G.O. first cited with retrospective effect from 1.9.93.
