Pension - Payment of family pension to the physically handicapped / disabled children with 100% disability and dispensing with the procedure of producing medical certificate every three year in case the disability is certified already at 100% - Orders - Issued.

ORDER:

As per clause (iii) in the proviso to sub-rule 6 to rule 49 of the Tamil Nadu Pension Rules, if a son or daughter of a Government servant is suffering from any disorder or disability of mind including mentally retarded or is physically crippled or disabled, family pension shall be payable to such son or daughter for life time through the guardian in the case of minor and to such son or daughter directly after he or she attains the age of major legally. Further, in the case of a mentally retarded son or daughter, family pension shall be payable to a person nominated by the Government servant or the pensioner and in case no nomination has been furnished to the Head of Office by the Government servant or the pensioner during his life time, family pension shall be payable to a person nominated by the spouse of the Government servant or the family pensioner. Further as per clause V in the proviso to sub-rule 6 of rule 49 of the Tamil Nadu Pension Rules 1978, the person receiving the family pension as guardian or such son or daughter shall produce every three years a certificate obtained from a medical officer not below the rank of a Civil Surgeon to the effect that he or she continues to suffer from disorder or disability of mind or continues to be physically crippled or disabled.

2. Representation has been received by the Government that the pensioners shall be allowed to nominate guardian to receive family pension in the case of physically handicapped/ disabled children with 100%

disability and the procedure of producing medical certificate every three years by the guardian or physically handicapped / disabled children may be dispensed with in the case the disability is certified already at 100% and the deformities are permanent.

3. The Government after careful examination have decided to allow the Government servant / pensioners to nominate guardian to receive family pension in the case of physically handicapped / disabled children with 100% disability and to dispense with the procedure of producing medical certificate every three years by the guardian or the physically handicapped / disabled children in case the disability is certified already at 100%. Accordingly, the Government direct that in the case of physically handicapped / disabled children with 100% disability and the deformities are permanent, the Government servant or the pensioner, as the case may be, shall nominate a person to receive family pension on behalf of such children and in case no such nomination has been furnished to the Head of Office by such Government servant or pensioners, the spouse of the Government servant or family pensioner, as the case may be, shall nominate a person to receive family pension later on. The Government also direct that the procedure of producing medical certificate every three years by the guardian of handicapped / disabled children shall be dispensed with in the case of disability is certified at 100% and the deformities are permanent.

4. These orders, shall take effect from the date of issue.

5. Necessary amendments to the Tamil Nadu Pension Rules will be issued separately.
