ORDER:

In G.O., first read above, the Government, among others, have issued orders for upgradation of posts in the feeder category of Assistant Surgeons to strengthen the Health Care System in the State. It has also been ordered therein that the post of Civil Surgeon and Senior Civil Surgeon shall be inter-changeable, based on the need, subject to the Special rules / Adhoc rules governing the posts.

2) Subsequently in the G.O. second read above, the Government have accorded sanction for upgradation of 2000 posts of Senior Civil Surgeons, 1884 posts of Civil Surgeons and 1616 posts of Senior Assistant Surgeons in various Directorates of Health Department, as indicated in the Annexures to the Government order therein. Government have examined the proposal of further continuance of the upgraded posts beyond 31.3.1999. The Government after detailed examination accord sanction for further continuation of the above upgraded posts by the Director of Medical Education / Director of Medical & Rural Health Services / Director of Public Health & Preventive Medicine as mentioned in the Annexures to this order, for a period from 1.4.1999 upto 30.6.2002.

3) The orders for further continuance of the upgraded posts of Senior Civil Surgeons, Civil Surgeons and Senior Assistant Surgeons issued in G.Os fourth to tenth above stands cancelled.

4) The holders of the posts are eligible to draw in addition to Pay, D.A. and other allowances at the rates admissible as per the rules in force and orders issued from time to time.

5) The expenditure shall be debited to the relevant head of account of the respective institutions wherein the incumbents of the posts are working and drawing salary.

6) This order issues with the concurrence of Finance Department vide its U.O.No.34090/Health.2/2001-1, dated 30.5.2001.


