1. Thiru.R.Balasubramanian, Superintendent of PHC 7 section is transferred and posted to legal cell vice Tmt.J.R.Uma Maheswari, Superintendent, MP.II section.

Thiru.S.Driviam Sithar, Assistant of MP.II(S2) section who is presently dealing with court cases filed by Health Inspectors is posted to Legal cell alongwith the subject, except the files relating to according permission to Health Inspectors grade-I / Block Health Superior to retire from service on attaining their age of superannuation.
