

ORDER:

In accordance with the norms prescribed in the G.O. first read above, the Director of Public Health and Preventive Medicine has submitted a proposal for the conversion of the post of Personnel Officer in the Department of Public Health and Preventive Medicine into that of Joint Director (Admn) in the scale of pay of Rs. 3700-5000.

2. The Government after careful examination, have decided to upgrade one post of Administrative Officer/Administrative Personal Assistant in the Department of Public Health and Preventive Medicine into that of Deputy Director (Admn) in the scale of pay of Rs. 3000-100-3500-125-4500 withdrawing the post of Personal Officer (in the cadre of Deputy Secretary to Government in the Department of Public Health and Preventive Medicine.

3. The Officer holding the upgraded post of Deputy Director (Admn) in the Department of Public Health and Preventive Medicine shall be eligible to draw in addition to pay, ~~Dearness~~ Dearness Allowance and other allowances admissible under the rules in force from time to time.

4. The expenditure shall be debited to "2210. Medical and Public Health 06, Public Health - Direction and Administration - 1. Non-Plan - AA. Headquarters Administration - 01. Salaries (D.P.Code No. 2210.06.001 AA. 0102).

5. The Director of Public Health and Preventive Medicine is requested to send necessary panel of Administrative Officers/Administrative Personal Assistants of the Department of Public Health and Preventive Medicine to fill up the post of Deputy Director (Admn) of the Department of Public Health and Preventive Medicine.

6. This order issues with the concurrence of Finance (CMPC) Department vide its U.O. No. 13351/CMPC/94-1, dated 15.2.1994.


