

Sub: Fundamental Rules - Tamil Nadu Ministerial
Service/Tamil Nadu Judicial Ministerial Service -
Fixation of pay of Assistants promoted/appointed
from the posts of Typists and Steno Typists in-
cluding Selection Grade/Special Grade Typists
and Selection Grade Steno Typists.

Ref: G.O.Ms.No.139, Personnel and Administrative
Reforms (FR.I) Department, dated 10.5.95.

Representations have been received by the Government
requesting for revision of the mode of fixation ordered in the
Government order cited, in the case of Selection Grade
Typists/Ordinary Grade Steno Typist-Grade-III, and Selection
Grade Steno Typist -Grade-III, appointed as Assistants, since
it has been found to be disadvantageous to them. The represen-
tations have been examined in detail and the following amend-
ments are issued to the Government Order cited:-

AMENDMENTS :

1. For the existing mode of fixation viz., "As per the existing provisions in Ruling (14) under FR.27* ordered under Column.(2) in para 3.II. of the Government Order cited, the following shall be substituted:-

*As per ruling (8), read with ruling (9) under FR.22-B*without taking into account, the Special pay drawn in the post of Selection Grade Typist*.

ii) The existing mode of fixation, viz., "with reference to the provisions in Ruling (14) under FR.27, i.e. with reference to the notional pay drawn in the post of Selection Grade Typist*" ordered against item (iii) under column.(2) in para 3.III. of the Government Order cited, is deleted.

iii) For the existing mode of fixation ordered against items (i) and (ii) under Column.(2) in para 3.IV of the Government Order cited the following shall be substituted:-

* (i) Steno Typists, Grade-III promoted as Assistants during the period from 1.6.88 to 31.7.92 shall continue to draw the same pay (that drawn in the post of Steno Typist, Grade-III) till 31.7.92. On 1.8.92, the Special Pay drawn in the post of Steno-Typist, Grade-III shall be merged with basic pay, and pay fixed in the post of Assistant on 1.8.92* it under FR.22(2), i.e. at the same stage in the scale of pay Assistant*.

iv) The existing item (iii) under Column.(2) in para 3.IV. of the Government Order cited, shall be renumbered as item (ii).

v) For the existing mode of fixation ordered against items (i) and (ii) under Column.(2) in para 3.V. of the Government Order cited, the following shall be substituted:-

"(i) Selection Grade Steno Typists, Grade-III promoted as Assistants during the period from 1.6.'88 to 31.7.'92, shall continue to draw the same pay (as that drawn in the post of Selection Grade Steno Typist, Grade-III) till 31.7.'92. On 1.8.'92, the Special pay drawn in the post of Selection Grade Steno Typist, Grade-III shall be merged with basic pay and pay fixed in the post of Assistant on 1.8.'92 itself, under FR.22(1)(b)(ii), i.e. at

the appropriate stage in the scale of pay of Assistant equal to the pay drawn by them in the post of Selection Grade Steno-Typist, Grade-III: if not, at the stage next below and the difference treated as 'Personal Pay', to be absorbed in future increments.

vi) The existing item (iii) under Column.(2) in para 3.V. of the Government Order cited shall be renumbered as item (ii). After so renumbering, the words 'Special Grade Steno, Typist, Grade-III' occurring in the said item shall be read as 'Selection Grade Steno Typist, Grade-III'

The above amendments shall take effect from 1.6.'88.

2. Selection Grade Typists promoted as Assistants should exercise option within one month from the date of promotion as Assistant. Option once exercised shall be final. If no option is exercised within the time limit, pay shall be fixed in the post of Assistant, on the date of promotion after adding one notional increment to the pay drawn in the Selection Grade Scale of the post of Typist without taking into account, the special pay drawn in that post.

3. Persons who have already been promoted as Assistants on or after 1.6.'88 but before issue of this letter and had their pay fixed in the post of Selection Grade Typist in the Tamil Nadu V Pay Commission scale of pay, shall be allowed to exercise revised option within two months from the date of issue of this letter.

4. As for Steno Typist, Grade-III and Selection Grade Typist, Grade-III, exercising option on promotion as Assistant does not arise.

5. The anomaly of junior drawing more pay than the senior consequent on the issue of these amendments shall be rectified, if the conditions in Ruling (2) under FR.22-B and conditions, if any, relating to this fixation in the Tamil Nadu Revised Scales Pay Rules, are satisfied.

6. Necessary Amendments to the Fundamental Rules will issue separately.
