Rules – Tamil Nadu Ministerial Service – Fixation of ratio for preparation of combined seniority list from the posts of Junior Assistants and Typists recruited in the same year - Amendment to rule 5(b) of the Special Rules for the Tamil Nadu Ministerial Service – Orders - Issued.

ORDER:

In the Government Order first read above, orders were issued by amending the Special Rules for the Tamil Nadu Ministerial Service by introducing a ratio among the Junior Assistants and Typists including Steno-typists for promotion to the post of Assistant. In the Government Order second read above, orders have been issued for cancelling the ratio among the Junior Assistants and Typists including steno-typists and revised procedures to be adopted for promotion to the post of Assistant based on the directions of the Tamil Nadu Administrative Tribunal in its order dated 27.11.1992. In the Government Order third read above, among other things the following amendments to rule 5 of the Special Rules for the Tamil Nadu Ministerial Service were issued in this regard:-

5(b) Promotion to the post of Assistant and to the posts which carry the scale of pay of Assistant, shall be filled up from qualified Junior Assistants and Typists from the combined inter-se-seniority list of the holders in these categories recruited in the same year, with reference to the date of regular appointment in the respective category:

(P.T.O)

Provided that the seniority among the Junior Assistants or the Typists as fixed by the Tamil Nadu Public Service Commission shall not be altered while fixing their inter-se-seniority.

3. In the above rule provision while merging two different categories for consideration of promotion, the date of appointment is being prescribed as criterion. Nowadays, the Tamil Nadu Public Service Commission is furnishing the select list for the both categories viz., Junior Assistant / Typist on the same day through its common recruitment / Exam Group-IV. Consequently, the candidates are happened to be appointed on same day. In such case, the application of the existing rule provisions could not be followed for preparation of combined seniority list.

4. In order to resolve the issue, the Government after careful examination has decided to fix a ratio between two different categories (i.e. Junior Assistant and Typist) for preparation of combined seniority list to consider for promotion to the post of Assistant. Accordingly, to give equal proportion to both the categories, a ratio of 1:1 is prescribed for preparation of combined seniority of Junior Assistants and Typists who are recruited in the same year for consideration for promotion to the post of Assistant.

5. Accordingly, the Government amend sub-rule (b) of rule 5 of the Special Rules for the Tamil Nadu Ministerial Service.

6. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume - III of the Tamil Nadu Services Manual, 2016):-

AMENDMENT.

In the said Special Rules, in rule 5, for sub-rule (b) and the proviso thereto, the following sub-rule shall be substituted, namely:-

"(b) Promotion to the post of Assistant and to the posts which carry the scale of pay of Assistant, shall be made from the qualified Junior Assistants and Typists from the combined inter-se-seniority list of the holders in these categories recruited in the same year in the ratio of 1:1."
