ORDER:

In the Government Order ninth read above, the Government issued orders changing the names of certain Revenue districts. The Registrar, High Court has sent proposal for change of certain Judicial districts and for publication of notifications in the Tamil Nadu Government Gazette changing the names of certain District Court and certain Sessions divisions:

NOTIFICATION I

In exercise of the powers conferred by section 3 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby makes the following amendment to the Home Department Notification No.II(2)/HO/5861/m/79, dated the 16th September 1979, published at page 1 of part II - Section 2 of the Tamil Nadu Government Gazette Extraordinary, dated the 16th September 1979:-

AMENDMENT

In the said Notification, for the expression "the District Court of Periyar district at Erode", the expression "the District Court of Erode" shall be substituted.

NOTIFICATION II

In exercise of the powers conferred by sub-section of section 7 and sub-section (1) of section 9 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby makes the following amendment to the Home Department Notification No. II(2)/HO/5861 (r)/79, dated the 16th September 1979, published at page 3 of part II Section 2 of the Tamil Nadu Government Gazette, Extraordinary, dated the 16th September 1979.

AMENDMENT

In the said Notification, for the expression "Periyar District" wherever it occurs, the expression "Erode district" shall be substituted.

NOTIFICATION III

In exercise of the powers conferred by section 3 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby makes the following amendments to the Home Department Notification No. II(2) HO/6621 (g-1)/86, dated the 19th September 1986, published at page 1 of part-II-Section 2 of the Tamil Nadu Government Gazette Extraordinary, dated the 19th September 1986:-

AMENDMENT

In the said Notification, --

(i) for the expression "in Chidambaranar district", the expression "in Thoothukudi district" shall be substituted, and

(ii) for the expression "District Court at Tuticorin for Chidambaranar district to be styled as "The District Court of Chidambaranar district", the expression "District Court at Thoothukudi for Thoothukudi district to be styled as "the District Court of Thoothukudi" shall be substituted.

NOTIFICATION IV
