The One Man Commission among other things, has recommended enhancement of the special pay by 100% to those employees who were sanctioned with special pay prior to 31.12.90 and by 50% to those employees sanctioned with special pay after 31.12.90 following the orders of Government of India, issued in the reference third read above.
