

ORDER:

The following Notification will be published in the Tamil Nadu Government Gazette:

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Pension Rules, 1978.

AMENDMENTS.

In the said rules,-

(1) in rule 58, in sub-rule 6, the expression "and the audit enfacement on Section I of Part III of Form 7" shall be omitted;

(2) in rule 68,-

(a) in sub-rule (1) the expression "record his audit enfacement on Section I of Part II of Form 7" shall be omitted; and

(b) in sub-rule (7), the words "his audit enfacement and shall be omitted; and

(3) for Form 7, the following shall be substituted, namely:-
