



PENSION - Tamil Nadu Pension Rules, 1978 - Amendment to rule 49 of the Tamil Nadu Pension Rules, 1978 - Orders - Issued.

ORDER:

The following Notification will be published in the Tamil Nadu Government Gazette :-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Pension Rules, 1978.

2. The amendment hereby made shall be deemed to have come into force on the 1st January, 1979.

AMENDMENT

In the said Rules, in rule 49, in sub-rule(13), in clause (b), for sub-clause (iii), the following sub-clause shall be substituted, namely :-

"(iii) father, failing which the mother, in the case of an unmarried Government servant subject to the condition that such person declares to be dependent on the deceased Government servant."
