ORDER:

The following Notification will be published in the Tamil Nadu Government Gazette:

NOTIFICATION.

In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Pension Rules, 1978.

2. The amendments hereby made shall be deemed to have come into force on the 1st January, 1979.

AMENDMENTS.

In the said Rules, -


- (1) in rule 45, in sub-rule 5, -  
(a) for clause (iii), the following clause shall be substituted, namely:-

"(iii) sons including step sons, adopted sons and sons born through illegitimate wife".

- (b) for clause (iv), the following clause shall be substituted, namely:-

"(iv) unmarried daughters including step daughters, adopted daughters and unmarried daughters born through illegitimate wife", and

(c) for clause (v), the following clause shall be substituted, namely:-

"(v) Widowed daughters including step daughters, adopted daughters and widowed daughters born through illegitimate wife".

(2) in rule 46, in Note-(ii), in clause (b), sub-clause (i) shall be omitted.

(3) in rule 49, in sub-rule (13), in clause (b), in sub-clause (ii), for the words "including such son and daughter adopted legally," the words "including such son or daughter legally adopted and also such son or unmarried daughter born through illegitimate wife" shall be substituted.

(4) in Form 3, under the heading "Family for this purpose means," in item (c), after the words "including such son or daughter adopted legally", the words " and also such son or unmarried daughter born through illegitimate wife" shall be added; and

(5) in Form 11, for the words "including step children and adopted children" the words, "including step children, adopted children and children born through illegitimate wife" shall be substituted."
