ORDER:-

Prior to 1.1.96, Office Assistants and Duffadars were getting fixed rates of Compensatory Personal Pay as ordered in the Government Order first read above in view of the enforcement of work norm for employment of Office Assistant. They are not getting Personal Pay in the revised scales of pay after 1.1.96 due to merger of personal pay in the fixation of pay. Representations have been made by the Tamil Nadu Office Assistants and Basic Servants Association for grant of 5% of pay as Personal Pay as granted to other categories in the Government Order third read above.

2. The Government has carefully examined the request of the Association. These categories were granted with Personal Pay on fixed rates since 1.8.92, while enforcing work norm, resulting in consequential increase in workload. Taking into account the continuance and strict enforcement of work load norms in the appointment of Office Assistant and also the sanction of Personal Pay to certain specified categories in the Government Order third read above, the Government has decided to sanction compensatory personal pay.

3. Accordingly, Government sanction payment of Personal Pay to Office Assistants and Duffadars who are in service as on 1.9.1999 at the following rates:-

Ordinary Grade: Rs.30/- p.m.
 Selection Grade: Rs.55/- p.m.
 Special Grade: Rs.75/- p.m.

The Personal pay fixed as on 1.9.1999 shall be continued as such even after movement to Selection Grade or Special Grade. The Personal Pay will be absorbed in the fixation of pay at the time of next pay revision made by Pay Commission/Committee. The personal pay will not be applicable to the new entrants in the category of Office Assistants on or after 1st September 1999. This personal pay is a gesture by the Government as part of the norm rationalisation process. It is not an entitlement.

4. These orders shall also apply to Office Assistants in Local Bodies and Aided Educational Institutions.

5. These orders will come into effect from 1.9.1999.


