

Abstract: Tribal Welfare - Opening of Primary Health Centre at Kilakadu Kalrayan Hills of South Arcot District under Tribal Sub Plan for 1987-88 - Temporary post sanctioned - Revival orders - issued

In the G.O. first read above, the Government have accorded sanction for the establishment of a new Primary Health Centres at Kilakadu in Kairayan Hills of South Arcot District. But, the above Primary Health Centre could not be opened due to certain administrative reasons. Subsequently, the Director of Primary Health Centre has requested the Government to issue orders to establish the Primary Health Centre at Kilakadu and to provide necessary infrastructural facilities. Accordingly, in the letter third read above, the Government have permitted the Director of Primary Health Centre at Kilakadu, Kairayan Hills of South Arcot District, which was originally sanctioned in the G.O. first read above. The Director of Primary Health Centre has also been requested to send necessary proposals for the revival of the posts already sanctioned for the establishment of a Primary Health Centre at Kilakadu. // to establish a primary Health Centre

2. Now, the Director of Primary Health Centre has sent proposals to issue revival orders for the posts sanctioned in the Government order first read above and also for the post of Driver already sanctioned in G.O. Ms. No. 215, Social Welfare Department dt. 28.2.88.

3. The Government have examined the proposal of the Director of Primary Health Centre and have decided to accept it. Fresh sanction is accorded for creation of the following posts which were originally sanctioned in G.O. Ms. No. 2396, Social Welfare Department dt. 23.11.87 and in G.O. Ms. No. 215, Social Welfare Department dt. 26.2.88 for a period of one year from the date of employment or till the need therefor ceases, whichever is earlier, to work in the Primary Health Centre at Kilakadu, Kairayan hills of South Arcot District;-

4. The incumbents of the posts are eligible to draw Dearness Allowance and all other allowance at the rates admissible under the orders in force.

5. The expenditure should be debited to "2210-Medical and Public Health-03-Rural Health Services 796.Tribal areas Sub-Plan-Schemes in Eighth five year plan-II-States Plan-III-Primary Health centres in Tribal areas (D.F.Code 2210-03-796-JL 0007).
