ORDER:

The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special rules for the Tamil Nadu Public Health Subordinate Service (Section 26 in Volume - III of the Tamil Nadu Services Manual 1987).

2. The amendments hereby made shall be deemed to have come into force with effect from and from the 13th February 2000.

AMENDMENTS.

In the said special rules,

(1) in rule 2, in sub rule (a), in the Tabular column, under the heading "CLASS-I" for the item 2 in the second column, against the entry, "30 driver" in the first thereof, the following item shall be substituted, namely:-

"(2) Recruitment by transfer from among the holders of the post of Office Assistant, Cleaner / Van Cleaner and Watchman in the Tamil Nadu Basic Service in the Department of Public Health and Preventive Medicine and in the Department of Tamil Nadu State Health Transport".

(2) in rule 3, for sub-rule(2), the following sub-rule shall be substituted, namely:-
"(2) The appointing authority for the post of Driver shall be the respective Heads of the Offices under the Department of Public Health and Preventive Medicine who shall be not below the rank of Health Officer in Moffusil Offices and the Joint Director (Adm) in the Office of the Director of Public Health and Preventive Medicine, in Headquarters and the Director, Tamil Nadu State Health Transport, Department in respect of the Offices coming under the control of Tamil Nadu State Health Transport Department."

(3) in rule 9, for sub-rule (c), the following sub-rule shall be substituted, namely:-

"(c) Posting and transfer of Driver within the District shall be made by the respective Deputy Director of Health Services of the District and inter district transfers shall be made by the Director of Public Health and Preventive Medicine and by the Director, Tamil Nadu State Health Transport Department, in respect of the offices coming under the control of Tamil Nadu State Health Transport Department".
