ORDER.

There are 1419 Primary Health Centres at present  
in Tamil Nadu. Consequent on the increase in the number  
of Primary Health Centres in the State the administrative  
work relating to establishment matters of medical and  
paramedical staff has increased tremendously. To improve  
the efficiency of administration and quality of services  
rendered by Primary Health Centres and provide for  
single line command the medical health Centres and provide  
officers in Primary Health Centres who were hitherto  
under the control of Director of Medical and Rural Health  
Services have been transferred to and brought under the  
control of Director of Public Health and Preventive  
medicine recently. Consequently the administrative work  
has increased considerably. The Government have therefore  
decided to strengthen the PNC in the Office of the  
Director of Public Health and Preventive medicine, Chennai.6.

2. Accordingly sanction is accorded for the creation  
of the posts as mentioned in the annexure to this order  
on temporary basis for strengthening the administration of  
Primary Health Centres wing for a period of one year from  
the date of employment or till the necessity ceases whichever  
is earlier.

3. The holders of the posts are eligible to draw in  
addition to pay, the usual allowances at the rates  
admissible as per the rules in forces and orders issued  
from time to time.

4. Sanction is also accorded to incur an expenditure  
of Rs.9,18,000 (Rupees nine lakhs and eighteen thousand  
only) as follows:

- i) Recurring Expenditure towards staff cost Rs.5,99,000
- ii) Non recurring expenditure towards  
furniture and stationery for computer Rs.1,70,000  
and
- iii) Non recurring expenditure towards  
purchase of computer Rs.1,40,000

5. The Expenditure in respect of recurring and non recurring shall be debited to "2210. medical and public health-06. Public health 001, Direction and administration schemes in the ninth five year plan-11 State Plan JC Directorate of Primary Health Centre 01 salaries, D.C. No. 2210-06-001, JC 0109, 0.5 office expenses, 02. other contingencies pursuant to DPC 2210-06-004 (~~14C-2210-06-001-11-1911~~ JC 529), 19 machinery and equipments 01 Purchase (DPC 2210-06-001, JC 1911).
