#### **ORDER:-**

The Director, (i/c) Tamil Nadu State Health Transport Department, Chennai, In his letter read above has stated that the vehicle bearing No.TN-09-G-1546 Maruti Esteem used by the Director (i/c) of this Department has been condemned and subsequently the above vehicle has been auctioned and disposed off. As the Director is now stated that without a vehicle, great hardships are faced and essential inspections and other important official duties required to be carried out by the Head of the department could not be carried out. Hence, a replacement of vehicle for the above said condemned vehicle is very essential for which an amount of Rs 6,50,000/- may be sanctioned for purchasing a new vehicle under Part-II Scheme for the year 2014- 2015.

2. The Director, (i/c.) Tamil Nadu State Health Transport Department, Chennai has therefore requested to sanction a sum of Rs.6.50 Lakhs (Rupees Six Lakhs and Fifty Thousand only) towards the purchase of new vehicle against to the condemned vehicle under Part-II Scheme 2014-2015.
